TERMS

All purchases are subject to a 2% discount if paid by the 10th of the month following the month of purchase, unless the amount specified is NET, in which case the full amount is due by the end of that month. Purchaser agrees to pay a past due fee of 1.50% per month on all amounts which have not been paid by the end of the following month of purchase. Past due fees will be added to purchaser's account and used to compute past due fees for succeeding months.

Purchaser agrees to be liable for all costs of collection and attorney fees incurred by Reese Central Wholesale to collect any amounts owed by purchaser which have not been paid by the end of the month following the month of purchase. Buyer and Seller agree that in the event Seller commences litigation to collect amounts due hereunder, Seller shall be authorized to commence such action in Marion County, Indiana. If legal action becomes necessary by either the seller or buyer, it is also agreed that this agreement will be governed as to validity, interpretation, construction, effect, and all other respects by the laws of the state of Indiana.

Purchaser further agrees that any line of credit desired or approved is not a limitation of liability, and the undersigned expressly agrees that it will be responsible for valid charges in excess of a line of credit either desired or approved. The sale of materials by Reese Central Wholesale, Inc. to Purchaser shall be governed by the terms contained herein as well as all terms on the counter ticket and invoice that relate to particular transaction, which terms are incorporated herein by reference. 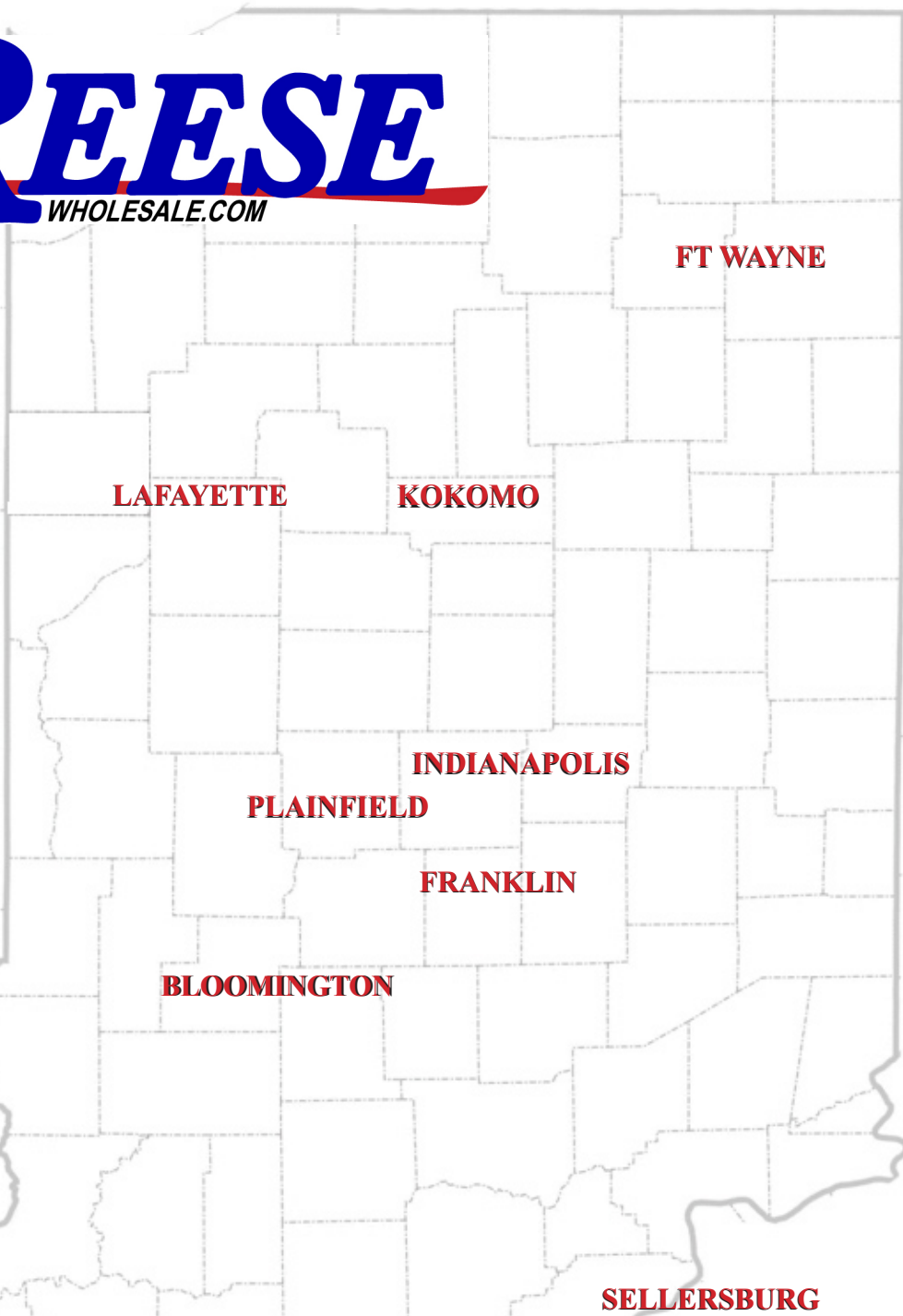
